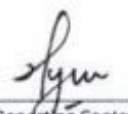

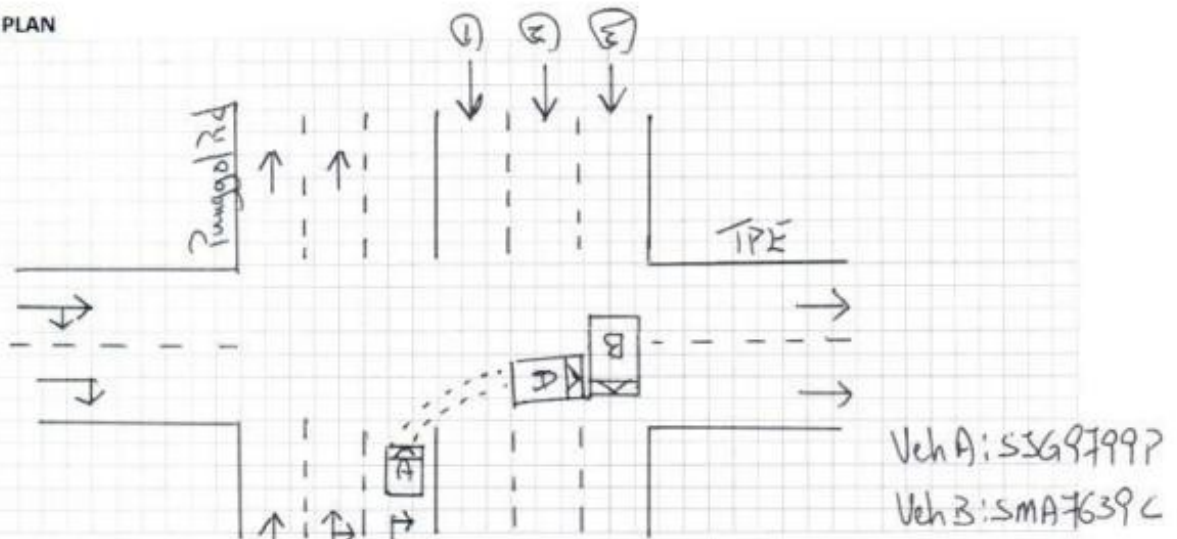

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 29/08/18 at approximately 2.15pm, I was driving along punggol road towards Sengkang at Punggol Flyover. When I approach the junction at punggol road / TPE, it was green light in my favour for going straight and turning right, thus I proceeded turning right towards TPE.

Before negotiating the right turn I notice all the cars at the 3 lane opposite direction were stationary due to the red traffic light. Suddenly, ~~vech~~ vehicle B dash out from a stationary position. I horned and tried to jam brake however it was too late and my car front portion collided with his car front right portion.

We got out of the vehicle and the driver admitted that it was his wrong for moving off as he saw a sudden movement by his side and never check the traffic light.

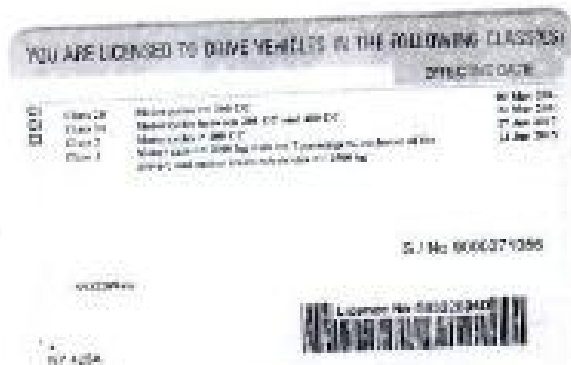
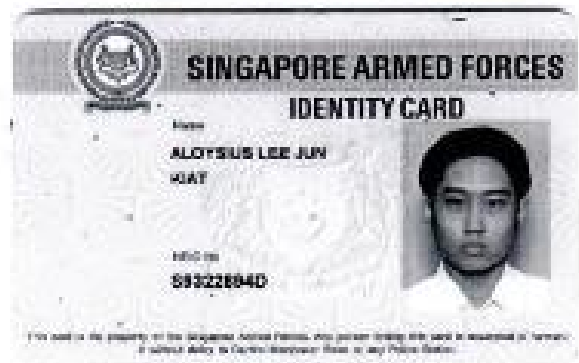
