NOTICE OF COMPLIANCE

This is to confirm that Wee Yoong Teck Peter, NRIC S1503543I, has reported to the Police a non-injury traffic accident which occurred at 681 Punggol Drive, Oasis Terrace, drop off point.

On the right side of my taxi, there was a white company van, GBG1528C. The van which was stopping on the pedestrian crossing then wanted to move off and reversed into my taxi. At the point of time, my taxi was already stationary.

Both me and the driver of the can then alighted our vehicle and took pictures of the accident and damages. However, he refused to exchange particulars with me.

Due to the impact, the driver door was dented which caused difficulty in opening and closing the door.
