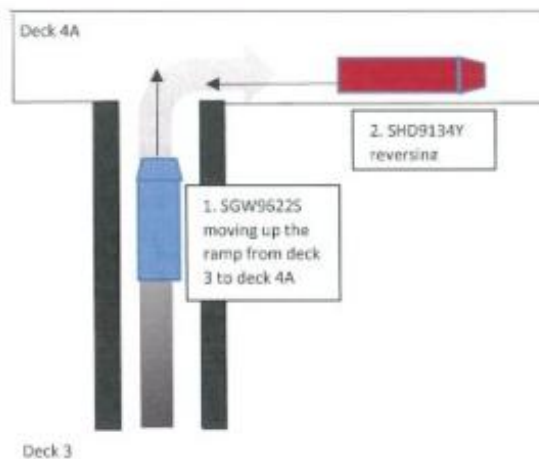
STATEMENT REGARDING COLLISION BETWEEN VEHICLES SGW9622S AND SHD9134Y ON 26 AUG 18

On 26 August 2018, 1602, Mr. Lee Jun Wei, Christopher drove vehicle (SGW9622S) out of his parking lot on deck 3. He drove onto the ramp leading up to deck 4A. Near the end of the ramp, he saw Mr. Tan Ah Choon's vehicle (SHD9134Y) on deck 4A reversing right to left, against the direction of traffic. Mr. Lee stopped his car on the ramp. Seeing Mr. Tan continue to reverse, Mr. Lee gave a prolonged horn. Mr. Tan continued to reverse, causing his rear right bumper to collide with Mr. Lee's front right bumper.

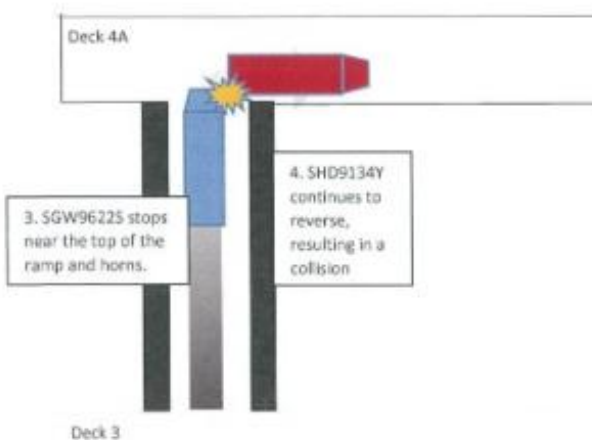
After the impact, Mr. Tan drove forward away from Mr. Lee's car, and the two came out to inspect the damage. Mr. Lee took photo of his front bumper (Photo 1), which displayed a significant dent on its bottom right corner. Mr. Lee took a photo of Mr. Tan's rear bumper (Photo 2 and Photo 3), which showed minor scratches on its bottom right corner. The two exchanged contact details before driving off.

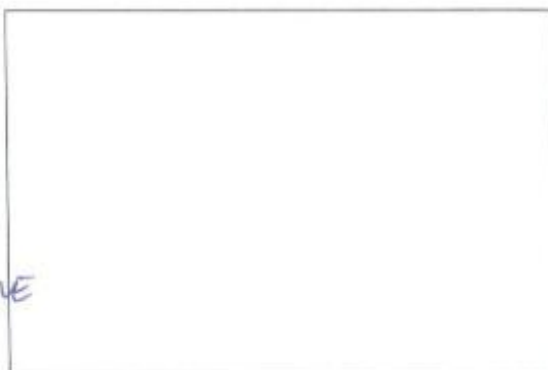
