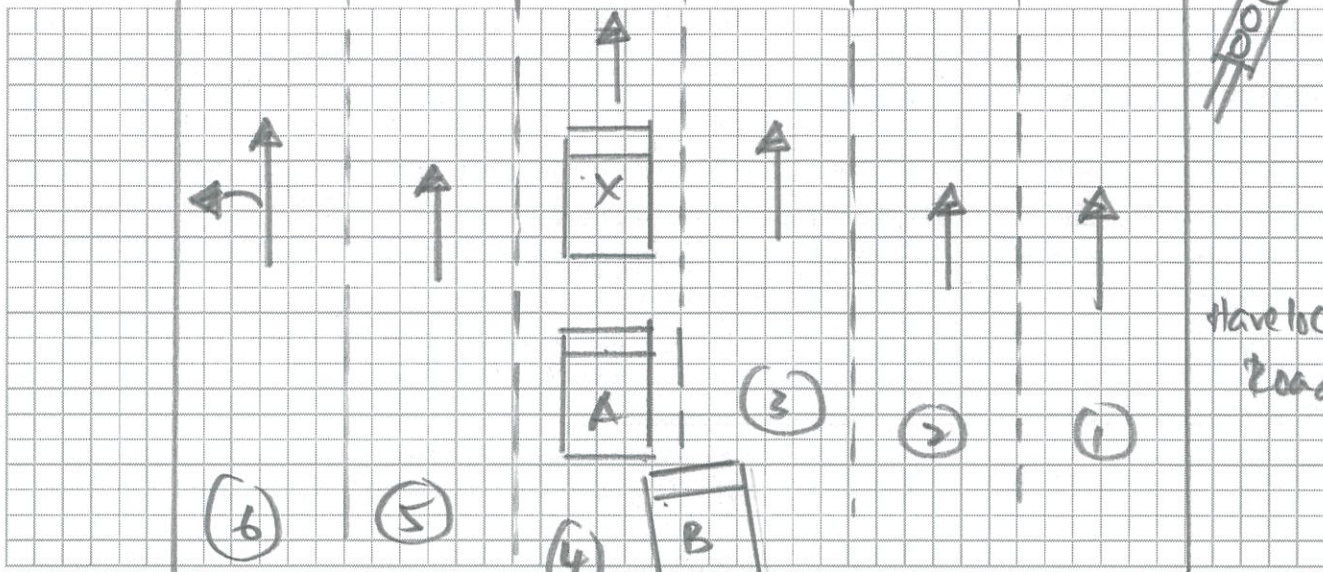
Failing which, we have no alternative but to proceed with the necessary repairs and the bill will be forward to you for reimbursement.

Describe Circumstance of the Accident.

ON 29/08/2018 @ 2340HRS, I WAS DRIVING MY TAXI (SHD 1919 C) TRAVELLING ALONG HAVELOCK ROAD TOWARDS THE TRAFFIC LIGHT JUNCTION OF NEW MARKET ROAD, IN LANE 4.

I STOPPED MY TAXI AS VEHICLES AHEAD OF ME STOPPED DUE TO RED TRAFFIC LIGHT.

WHILE STATIONARY, SUDDENLY I FELT AN IMPACT FROM THE REAR.

WHEN INSPECTED, I DISCOVERED THAT VEHICLE B (SJN 3565 A – TOYOTA WISH) WHICH WAS INITALLY IN LANE 3, HAD ENCROACHED & COLLIDED ONTO THE RIGHT REAR OF MY TAXI WHILE HE WAS FILTERING INTO MY LANE.

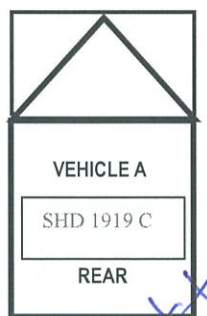

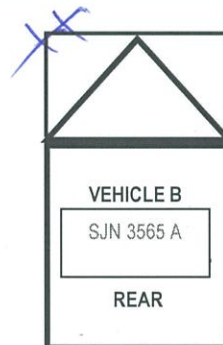
