Brief Details.

On 21/08/2018 at about 1530hrs, I was riding my motorcycle, FBL893C along East Coast Expressway towards Changi when I met up with an accident involving another van, GBA8212Z near to Marine Parade exit. I was riding on the second lane when I noticed all vehicles in front of me, along the highway started to slow down as such, I also slowed down my speed. It was then when I felt an impact from the rear of my bike. I could not recall what happened when I fell off my bike but I knew that I was few feet away from my bike which was behind me. I fell towards the left side of my bike as most of my injuries suffered, was from the left. After which, I was conveyed to the hospital by ambulance. The traffic police also came down to scene to take my particulars. I suffered abrasions on my left arm, right and left legs and I felt pain on my rip cage area.
