
**Circumstances of Accident** 

#straightroad Changing lane & Moving in own Lane Blue Car GBE4775X White Car unknown On 31 Aug 2018 around 2pm i was driving my company van along bukit timah rd near kampong java Junction. As i am driving on the centre lane and was going to turn into caveng road. I signal left and check the left mirror the left lane is clear and the nearest car (incident car) behind is at a distance away and since it is raining i double check again for the blind spot and began to filter to the left most lane. 


