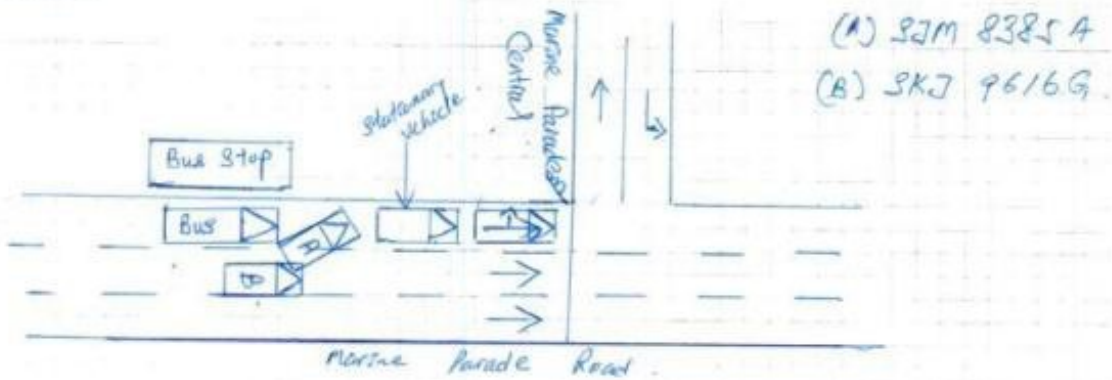

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 01/09/18 at @ 1600 hrs, I was travelling in my vehicle (SYM 8385 A) along Marine Parade Road before Marine Parade Central on the central lane. I saw a bus stopped at the bus-stop and after overtaking the bus, I signal left and change into the extreme left lane and stopped due to traffic jammed ahead. After the collision, the said vehicle did not stop and went straight and make a illegal turn from the central lane into Marine Parade Central. 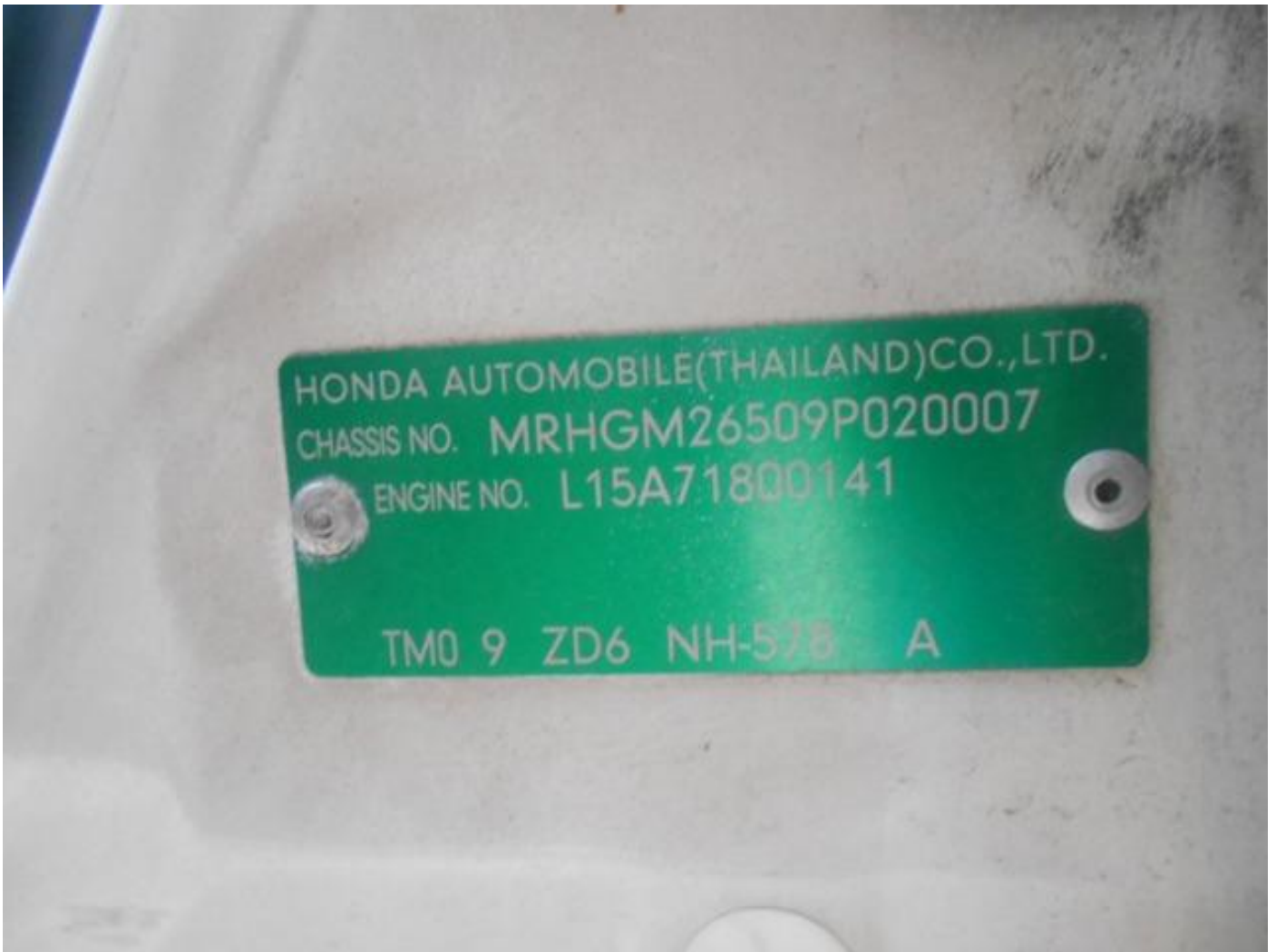
