

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

AS I was driving along Kippax Road @ 1735, suddenly a Premier taxi (SHC 6342M) brake and I followed likewise. I was travelling at 60km/h and was about 7.5 car lengths behind the cab. As I was braking, I swerved to the right to avoid a direct impact. When I came to a complete stop the taxi which had hit another car in front suddenly jerked backwards and it hit the front left side of my car. My car suffered a dent of the lower bumper and my left headlamp was slightly dislodged.
