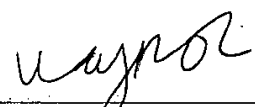

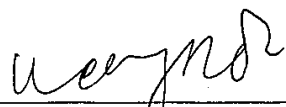

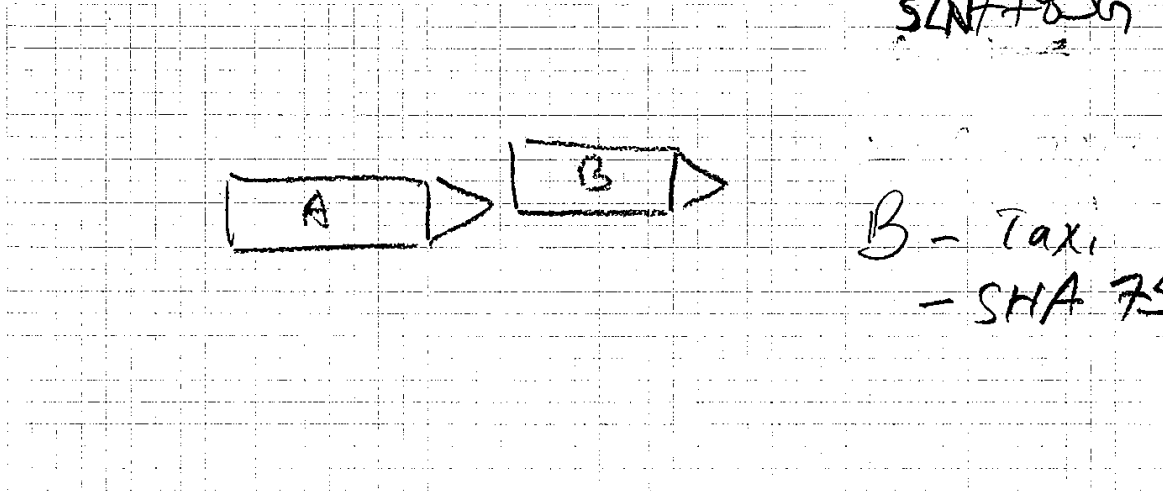

SKETCH PLAN

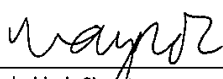

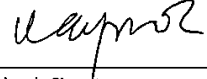
