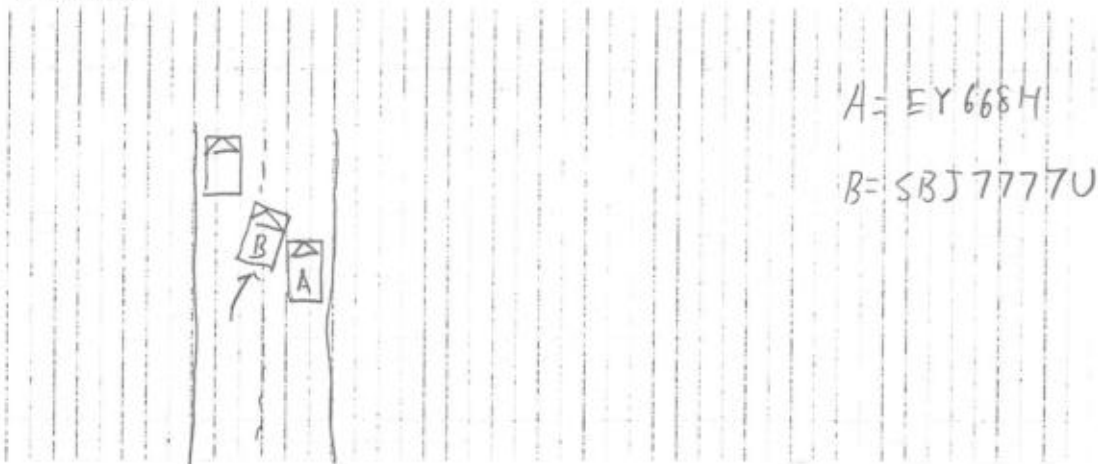

DESCRIPTION OF ACCIDENT

On 2 September 2018 at approximately 6:05pm, I was seated in my stationary vehicle (Audi A5 Reg No. EY668H) on the driver seat, with my girlfriend Jaime Tan who is in the passenger seat, which was parked in front of her house no. 10 Begonia Walk.

At the time, there was also another stationary vehicle (Dark Purple Audi Reg No. SKG8024L) which was parked at the opposite side of the road, approximately one car length distance from my vehicle.

I then started my vehicle and began to slowly drive off ahead at a slow moving off speed (approx 1-2km/hour), moving less than 1 meter, when this other vehicle (White BMW Reg No SBJ777U) came from behind my vehicle at a very fast speed and tried to squeeze through the space in between my vehicle and the other parked stationary vehicle.

The white BMW Reg No SBJ777U cut into my vehicle and the right side of the white BMW hit the front left side of my vehicle and as a result my vehicle was damaged. The front left fender the front left where and tyre and also the left side of the front bumper of my vehicle was hit by the white BMW. The front bumped detached from my vehicle and fell to the ground.
