Brief Details.

On 04/09/2018 at about 1039hrs, I fetched a male passenger from 7 Siglap Drive and the destination that the passenger would be heading to was to Upper Serangoon Shopping Centre. The said passenger was seated on the left side of the back passenger seat.

On the same day at about 1050hrs, I was driving along Jalan Euros and my car was on the second lane. As I was driving, I noticed that the traffic light along Jalan Eunos heading towards Eunos Link had turn amber. Since there was a red light camera at the traffic light, I immediately stepped on the brake which caused my car to skid a little bit before coming to a stop. About three seconds after my car had came to a stop, I felt an impact coming from the rear which caused my car to slightly inch forward.

I immediately asked the passenger whether he was injured and he claimed that he was fine at that

moment. I then stepped out from my car and noticed another car (SCR 3318J) had collided onto the rear of the car. The driver of the said car then came out and approached me. Both drivers then took photos of the collision, exchanged particulars and contact number before driving off to prevent traffic from piling up. I then continued my journey and send the said passenger to his location. After alighting the passenger, I felt some strain on my neck and some pain on the back of my body. I Immediately went to Mount Alvernia Hospital to see the doctor. I was then given medication and 4 days of Medical Leave starting from 04/09/2018 till 07/09/2018.

I wish to state that my car has an in car camera but was only pointing to the front. No police or ambulance was called in during the accident.
