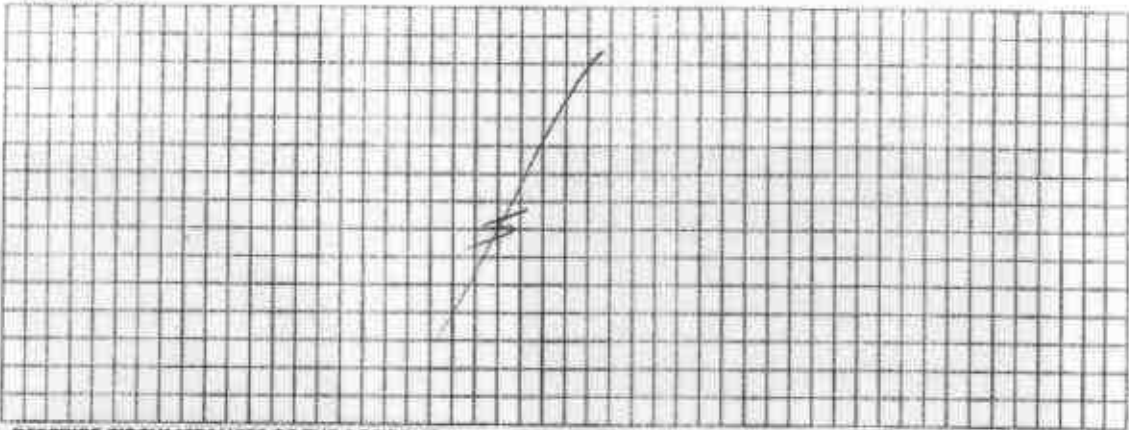

I am the owner and only driver of vehicle number SJV 1154Z which was involved in a fire incident on 27/8/18 at 0850 hours at carpark lot 106 at BLK 194 Pardon Loop, Patech Business Hub.

I was driving home to workplace at the aforementioned address. I took the BKE / PVE / AVE and exited at Clementi Ave 6. I normally head to fitness first gym at 321 Clementi before heading to office. I will workout for an hour and a half before proceeding to the office. I reached the office and parked my car at about 0850 hours. At about 0910 hours I got a call from my finance manager, Mr. Cheng that my car was on fire. I reached my car at about 0920 hours. By then the SCDF were already at the scene and were putting out the fire. There was a vehicle parked to the right of my car but I did not see it sustaining any damage. There was no car on right side when I arrived.

The SCDF took about half an hour to put out the fire. The front position of my car was severely burnt particularly on the left side. The fire activated the fire alarm, hence, both police and SCDF were activated and were present at the scene.

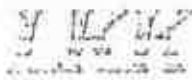

STATEMENT

I assisted the police and SCDF in their preliminary investigations. They authorized me to tow the car at about 1200 hours. I called the ATG hotline and made towing arrangements. The tow truck arrived at 1430 hours. By then the police and SCDF had left the incident scene. I hitched a ride with the tow personnel to Police Substation to lodge an insurance report. I went to the Ang Mo Kio Police Division the next day, 28/8/18 to make a police report.

I purchased the car new in Jan 2010 and I am the only driver for the past 8 years. I purchased a DVD player from China Sheng shortly after I bought my car. I had it fixed together with a reverse camera. I also purchased an after market audio system consisting of a sub-walker, an amplifier, 4 speakers and 2 tweeters. The amplifier and sub-walker are of 'Pioneer' brand and the speakers as well as tweeters are of 'Precision'. I had all these components fixed in my car at the same time at China Sheng and I have not changed any component for the last 8 years. Some painting was also done on the 4 doors of my car. There were no problems with the audio system for as long as I was driving my car.

I last serviced my car on 16/7/18 at Sam Hock Motor Services. I have been servicing the car at Sam Hock since I purchased it. The last servicing package consisted of engine oil, oil filter, front brake pads and lot of my tires was patched. As far as I can recall I only changed the aircon compressor 2 years ago. Other than that, it's the usual wear and tear.

On the day of the incident I did not encounter any mechanical, electrical/electronic or overheating issues with the car. Everything was running smoothly. I have no recollection what could have caused the fire.
