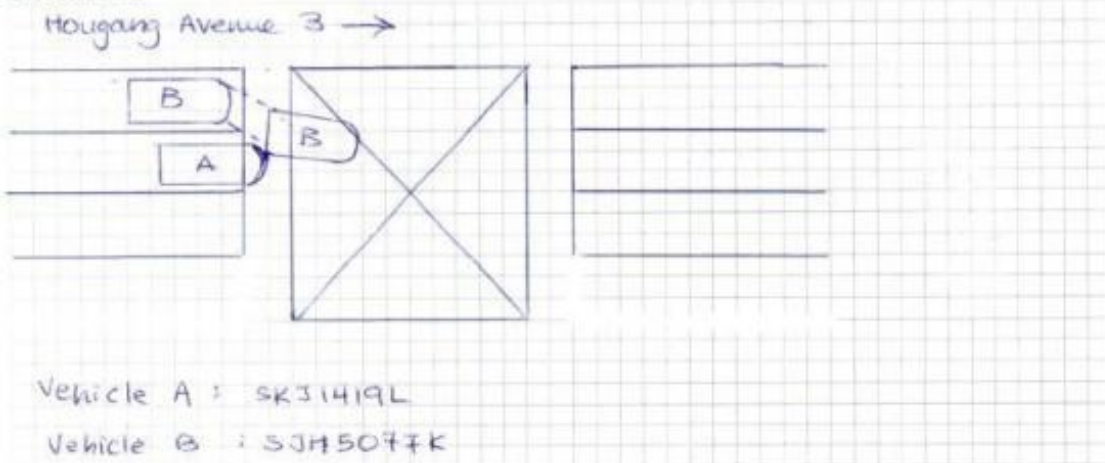

### DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 07 Sep 2018 at around 9:30pm, I was driving along Hougang Avenue 3 and was maintaining a straight course in my lane, when vehicle B while approaching the traffic junction had suddenly cut into my lane and jam braked at the traffic junction area.

As it was a suddenly move by vehicle B, I had applied my brakes but due to the proximity was unable to stop in time and had contacted vehicle B at the right tail side. There were road works ahead of the junction and the left lane that vehicle B was travelling on was closed ahead. This might be the reason why vehicle B had cut into my lane and realised it was a traffic junction and applied sudden brakes.
