We refer to the above subject matter. We write to inform you that we are the loss adjuster appointed by your motor insurer, AXA Insurance Pte Ltd to deal with the third party claim against your policy.

We have received a claim from ESTEEM PERFORMANCE PTE LTD acting on behalf of the owner of SLN 664T against your motor insurance policy.

Both parties involved have given conflict of version. Based on the circumstances of accident, there is no conclusive evidence to substantiate either's parties version.
