Describe Circumstances of the Accident

On 02.09.2018 around 6 pm, I was travelling along KPE heading back home with my spouse.

I was taking the PIE Exit towards Changi, on the right lane of the 2-lane PIE exit.

I noticed a vehicle NTUC taxi, STA 7565 R on my left lane. He had rear passengers.

As I approached, I noticed his taxi drifting right, onto my lane.

I quickly sounded my horn loudly but his vehicle continued drifting right towards my car.

I heard a cracking sound as my vehicle passed his and realised my left front door's rear view mirror has been badly damaged.

Our 2 vehicles then parked one after another in front of the divider, exiting PIE to Changi (right) and Tuas (left).

He requested if it nice to settle privately and apologised for veering onto my lane when I enquired why he driving in such a manner. Mr. Tan explained that he was conversing with his rear-seated Chinese passengers who were going to the Zoo.

He told me few times that his Insurance Excess is \$1,000 and can settle privately if my rear mirror repair is less than \$1,000.

I told him I do not know the costs until when Werner Fagnar inform me.
