On 09/09/2018, at about 1300hrs, I parked my car SLV8887Y at the open space car park near B/525 Bedok North St 3 as I was visiting my parents who are staying around there. After I parked my car, I then

At about 1430hrs. I returned to my car and I drove it back home without checking the condition. I reached the car park of my home at about 1445hrs. When I alighted and about to leave the car park, I realized the front bumper and the front left headlight were actually damaged. I then went to check my inbuilt car camera and I found out that at about 1336hrs, a silver Nissan lorry GZ7531T had hit onto my car when reversing. The driver of the lorry had alighted to make a check but he drove off after checking, without leaving a note for me regarding the incident. I also recalled that when I returned to my car, the driver was actually at scene as he was looking at me when I was putting my kids into my car. However,

I wish to state that the driver of the lorry is a male Chinese in his 60s. He was wearing a yellow polo-tee and a pair of black Bermuda when the incident happened. I have reported to my BMW workshop and they advised me to lodge a police report. My in-built car camera had captured the whole incident and I had saved a copy. I am willing to provide the video footage for police investigation purpose.





