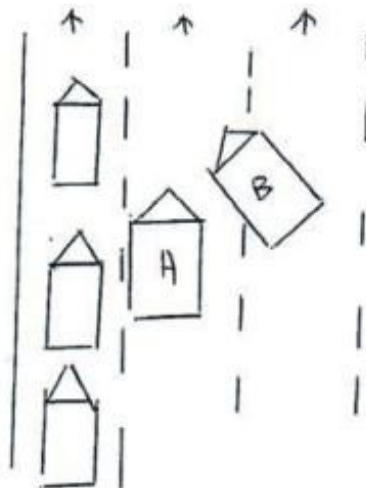

PORTION OF MY VEHICLE.

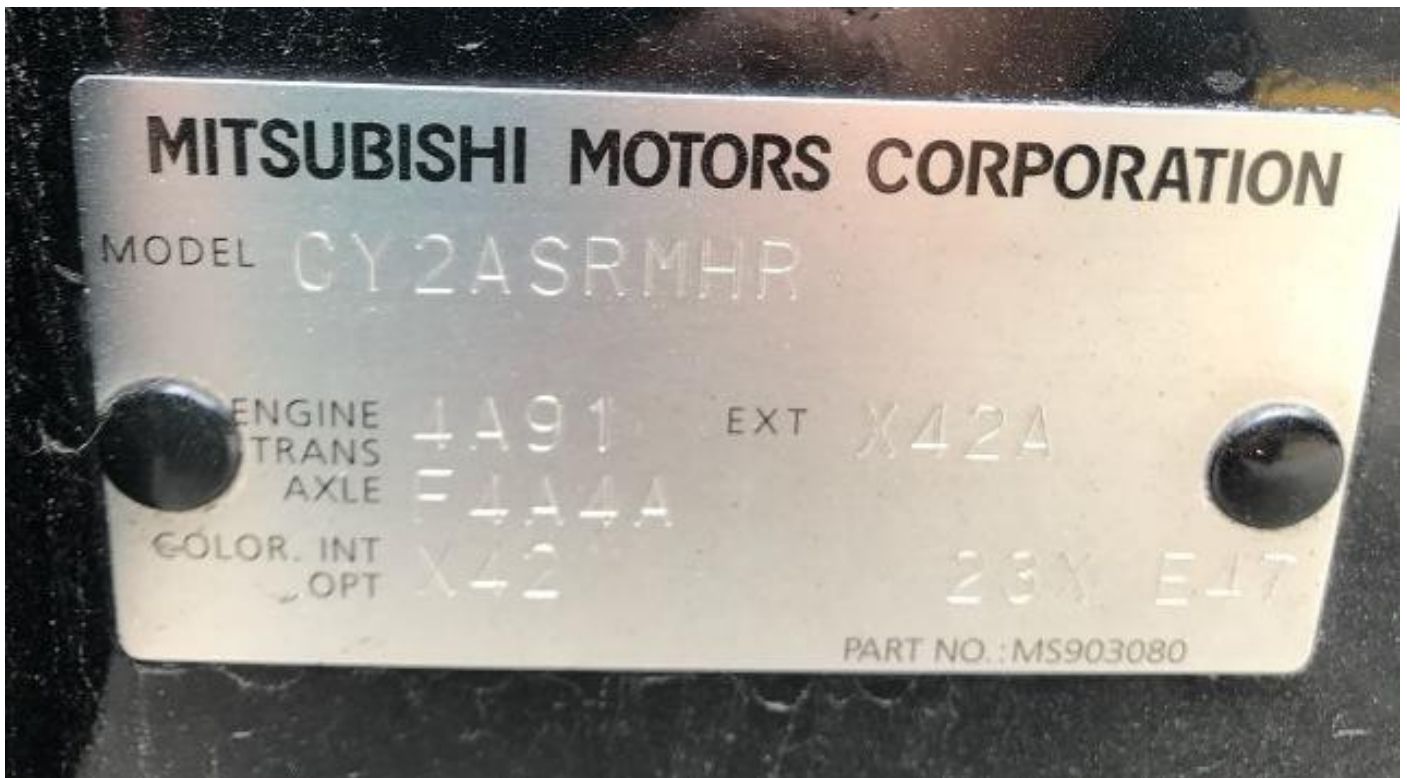

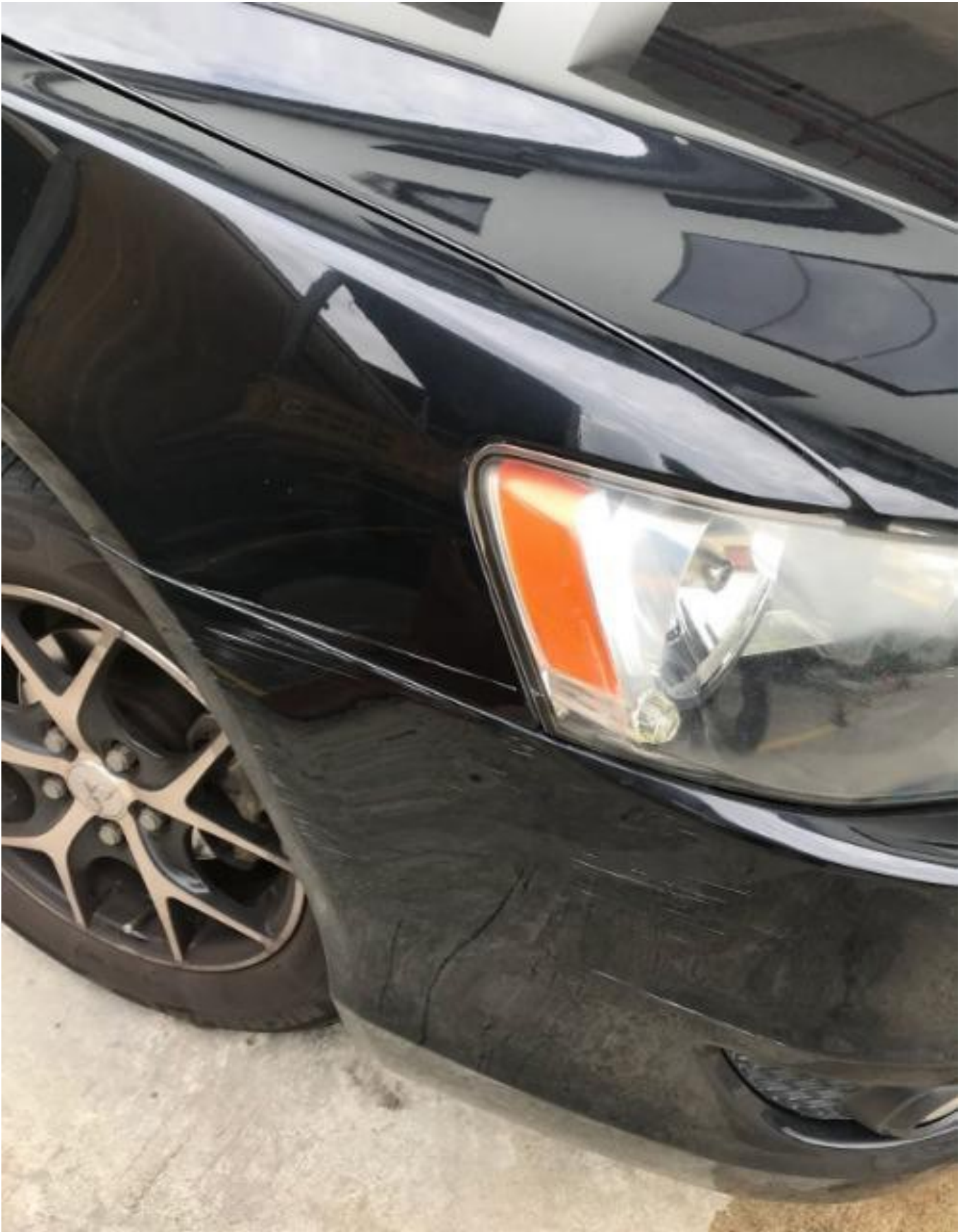
