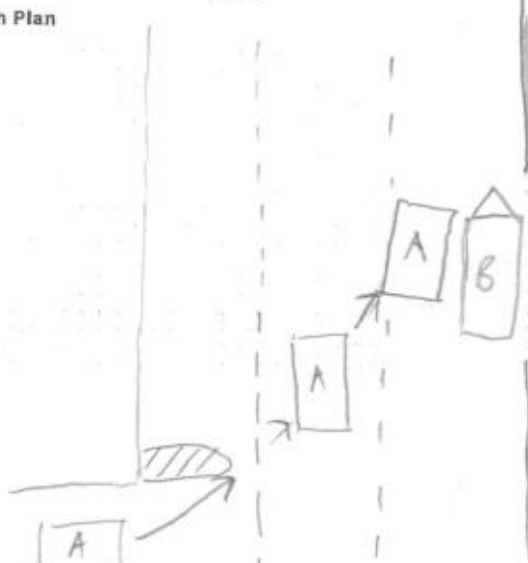

Describe Circumstances of the Accident

On Saturday, 8th September 2018, I was exiting the compound of Sin Ming Authority, located at 160 Sin Ming Drive. I ~~was~~ turned onto Sin Ming Drive, Lane 2 (As there was chevron markings on the floor that prevents me from turning into Lane 3.) I was transiting into Lane 2 when a black Mercedes E300 with the number plate SLP4358 R came from the rear and collided with my vehicle. I did not recall seeing the vehicle in my right view mirror. I'm not certain if the other vehicle changed lane from Lane 2 to Lane 1 as well. The other vehicle driver was a mechanic testing the vehicle. He remain quiet when I questioned if he was speeding. We both agree to let the insurers advise us the liability of the repairs. No one was injured in the incident.
