#### Circumstances of Accident

REFER TO POLICE REPORT - T/20180909/2073 LODGED AT BUKIT BATOK NPC. ON 09/09/2018 AT ABOUT 1100HRS, I WAS DRIVING MY BMW CAR WITH MY MOTHER-IN-LAW AND WAS EXITING THE CARPARK NEAR TO THE BUKIT BATOK CC. IT WAS RAINING HEAVILY BUT I SAW THAT THERE WAS A BLUE COMFORT TAXI EXITING THE CC DROP OFF POINT AND HE DID NOT STOP ALTHOUGH I WAS IN THE RIGHT OF WAY. AS A RESULT, THE TAXI HIT DIRECTLY ONTO THE DRIVER SIDE OF MY VEHICLE. THE DRIVER, A MIDDLE-AGED CHINESE MALE, DID SOME GESTURES AND I THOUGHT THAT HE TOLD ME TO STOP IN FRONT TO EXCHANGE PARTICULARS BEFORE THE EXIT GANTRY. HE THEN STOPPED AHEAD AND I PARKED BEHIND HIS TAXI. HE THEN ALIGHTED HIS VEHICLE AND TOOK OUT HIS UMBRELLA BUT HE TALKED TO ANOTHER DRIVER IN ANOTHER BLACK SUV CAR. THE DRIVER THEN WENT BACK INTO HIS TAXI AND DROVE OFF. I THEN TRIED TO FOLLOW THE TAXI BUT I LOST IT. I AM UNSURE IF HE HAVE ANY PASSENGER IN THE CAR. I LATER MADE A CHECK ON MY CAR AND DISCOVERED THAT THE DAMAGES ARE SOME LONG SCRATCHES TO THE RIGHT SIDE OF THE PASSENGER AND DRIVER DOORS AND DENTS TO THE DRIVER DOOR AND THE BODY FRAME NEAR IT. I HAVE SOME DIFFICULTY OPENING THE DRIVER DOOR. THERE IS NO INBUILT CAMERA IN MY CAR AND NOBODY IS INJURED.

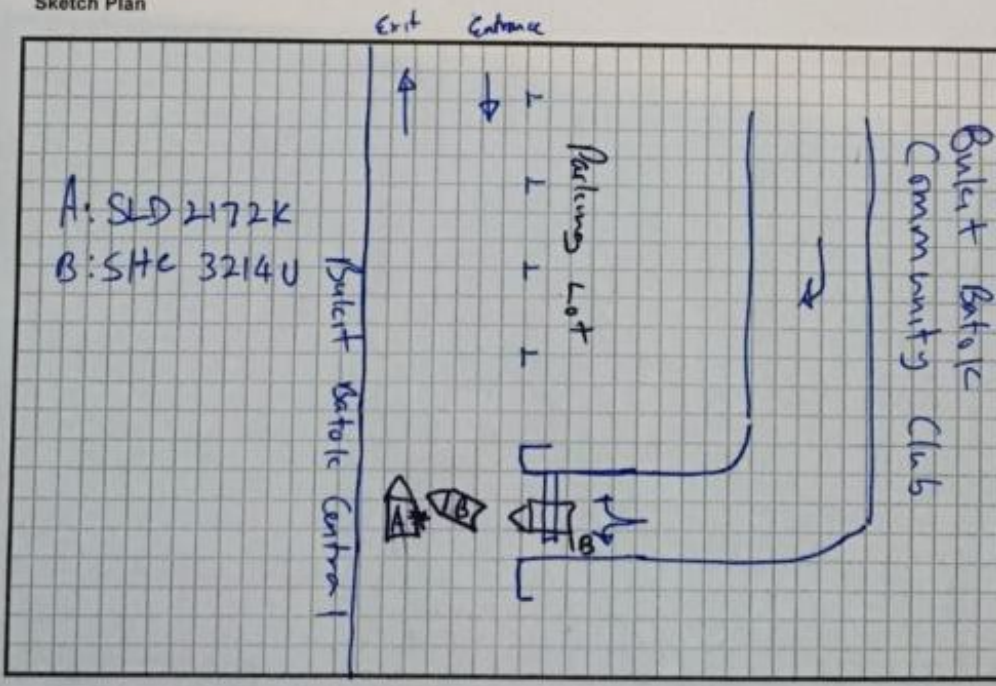

### Brief Details.

On 09/09/2018 at about 1100hrs, I was driving my BMW car with my mother-in-law and was exiting the carpark near to the Bukit Batok CC. It was raining heavily but I saw that there was a blue Comfort taxi exiting the CC drop off point and he did not stop although I was in the right of way. As a result, the taxi hit directly onto the driver side of my vehicle. The driver, a middle-aged Chinese male, did some gestures and I thought that he told me to stop in front to exchange particulars before the exit gantry. He then stopped ahead and I parked behind his taxi. He then alighted his vehicle and took out his umbrella but he talked to another driver in another black SUV car. The driver then went back into his taxi and drove off. I then tried to follow the taxi but I lost it. I am unsure if he have any passenger in the car. I later made a check on my car and discovered that the damages are some long scratches to the right side of the passenger and driver doors and dents to the driver door and the body frame near it. I have some difficulty opening the driver door. There is no inbuilt camera in my car and nobody is injured.


