## a) a) Case IAFP-IB-20180911 - Mechanical Inspection of Motorcycle, JQP 6420 (TP/IP/49129/2018)

On 30 August 2018 (Thursday) at 7.37 a.m., the Deceased was riding his motorcycle with his pillion, his wife along Ayer Rajah Expressway towards Marine Coastal Expressway L/P 244 on lane 4 of 4 lanes, near L/P 244, the Deceased collided onto the rear of the Involved Party's motorcycle and lost control of his motorcycle. The Deceased was pronounced dead at scene at 7.57 a.m. by the attending paramedic, SS Yap.

On 8 September 2018 (Saturday) at about 2.12 p.m., it was revealed that the Deceased was travelling ahead of the Witness and they were on their way to Johor Bahru, Malaysia. While travelling along BKE (Woodlands) near the 9.5 km marker, on lane 1 of the 3 lanes road, the Deceased collided into the rear portion of the Involved Party's motor car. Due to the collision, the Deceased and his motorcycle fell to the left and landed in between lanes 1 and 2. As a result of the accident, the Deceased was conveyed in a critical condition to Khoo Teck Puat Hospital. On the same day at 3.24 p.m., the Deceased succumbed to his injuries and was pronounced dead by Dr Yuen in the said hospital.
