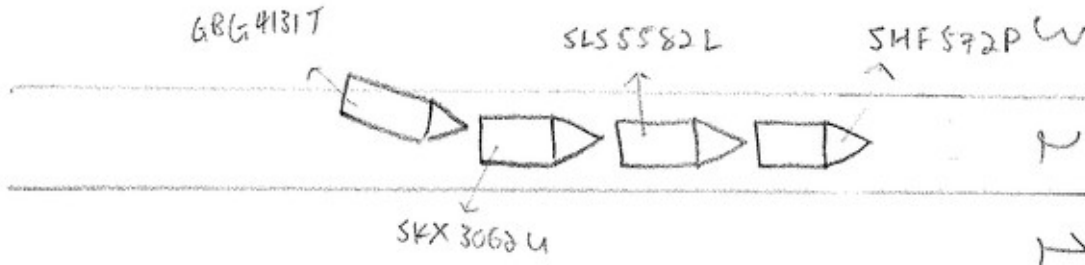

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 10 Sep 2018, 1930hrs

I was travelling on lane 2 and just exited KPE tunnel heading towards TPE. TAXI in front (CAR 1: SHF572P) stop abruptly and I had to do an emergency brake. I managed to stop in time and did not hit the taxi. However, the CAR behind me (SKX 3062U) hit me and the impact caused my car to jerk forward and hit the taxi in front of me. When I got down to inspect the damage, I realised that there was a 4th vehicle involved (CAR 4: GBG 4131 T). This lorry probably hit the CAR behind me (CAR 3: SKX 3062U) and caused the chain collision.

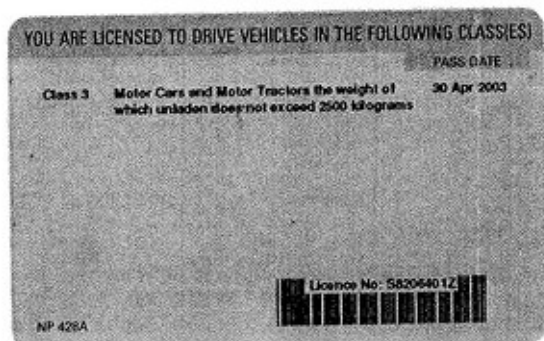
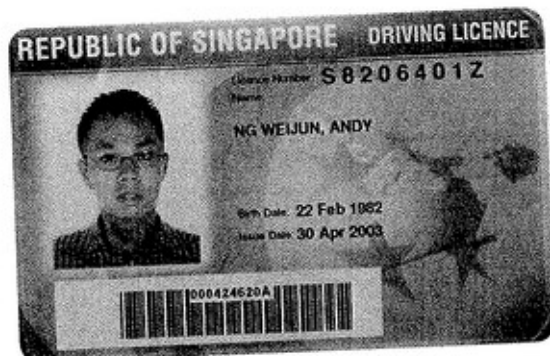
