REFER TO POLICE REPORT NO:T/20180825/2024 LODGED AT WOODLANDS EAST N.P.C. ON 24/08/2018 AT ABOUT 1320HRS, I WAS DRIVING MY VAN (GW9489K) ALONG LANE 2 OF PAYA LEBAR ROAD TOWARD TAISENG, AS I WAS HEADING TO KAMPONG UBI INDUSTRIAL ESTATE TO COLLECT DELIVERY. THERE IS A JAM AT THE AREA. ABOUT 15M BEFORE THE JUNCTION OF PAYA LEBAR ROAD TOWARDS TAISENG AND UBI AVE 2, I HAD STOP AS THERE WERE STILL MANY VEHICLES IN FRONT OF ME AND I HAD TO WAIT FOR THEM TO MOVE. SUDDENLY, I FELT A SLIGHT JERK FROM MY VAN. I EXITED MY VAN TO CHECK WHAT HAD HAPPENED AND REALIZE THAT THE FRONT OF A CAR (SJV3482M) HAD HIT ONTO THE REAR OF MY VAN. THE DRIVER OF THE CAR ALSO EXITED HIS CAR. WE DID A BRIEF CHECK ON OUR CARS AND THEN EXCHANGED HAND PHONE NUMBERS. HE INTRODUCED HIMSELF AS MR TAN HP:92977075. I ALSO CHECKED AND SAW THAT THE BACK OF MY VAN HAD ONLY MINOR SCRATCHES. NO ONE WAS INJURED DURING THE ACCIDENT. THE CHECK AND EXCHANGE OF PARTICULARS ONLY TOOK ABOUT 2-3 MINS. WE BOTH THEN LEFT THE SCENE.

**Brief Details.**

On 24/08/2018 at about 1320hrs, I was driving my van (GW9489K) along lane 2 of Paya Lebar Road towards Taiseng, as I was heading to Kampong Ubi Industrial Estate to collect delivery. There is a jam at the area.

About 15m before the junction of Paya Lebar Road towards Taiseng and Ubi Ave 2, I had to stop as there were still many vehicles in front of me, and I had to wait for them to move. Suddenly, I felt a slight jerk from my van. I exited my van to check what had happened, and realize that the front of a car (SVJ3482M) had hit onto the rear of my van. The driver of the car also exited his car. We did a brief check on our cars and then exchanged hand phone numbers. He introduced himself as Mr Tan, Hp: 92977075. I also checked and saw that the back of my van had only minor scratches.

No one was injured during the accident.

The check and exchange of particulars only took about 2-3mins. We both then left the scene.
