Brief Details.

On the 12/09/2018 at about 4p.m, I had parked my vehicle, SKQ50K (Merc/Black) at Pearls Centre multi-storey carpark level 2, (unknown lot no.) and left upon securing my vehicle. Subsequently at about 5.20p.m when I returned back to my vehicle, I noticed that my vehicle's front bumper and front lip was damaged. As my vehicle was fitted with an in-built camera, I proceeded down to my friend's workshop located at B/51 Ubi Ave 1 #01-21 to view the footage of my car's camera. Upon viewing the footage, there was a vehicle registration no.SLG9984Y which had actually side-grazed against my vehicle's front bumper and lip as the vehicle was making its way to exit the said carpark.
