

ON 13/09/2018 @ 1420HRS, I WAS DRIVING MY TAXI (SHB 8648 Z), TRAVELLING ALONG THE TRAFFIC LIGHT JUNCTION OF SIMEI AVE INTO SIMEI STREET 3, IN LANE 1 (ARROW ON ROAD SURFACE SHOWS RIGHT TURN ONLY).

TRAFFIC LIGHT AHEAD – SHOWED GREEN LIGHT & GREEN ARROW ON MY ROUTE FAVOUR & I PROCEED AHEAD – MAKING MY RIGHT TURN INTO SIMEI ST 3.

IN THE MIDST OF TURNING RIGHT, SUDDENLY VEHICLE B (YN 8582 P – MITSUBISHI LORRY) WHICH WAS INITIALLY IN LANE 2 (ARROW ON ROAD SURFACE SHOWS RIGHT TURN ONLY) – FAILED TO KEEP FOR PROPER LOOK OUT & ENCROACHED ONTO MY PATH ON MY LEFT ABRUPTLY.

AS SUCH, THE RIGHT PORTION OF VEHICLE B COLLIDED ONTO THE LEFT FRONT OF MY TAXI.

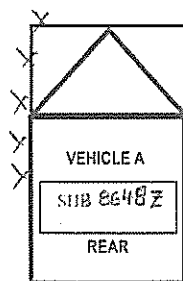

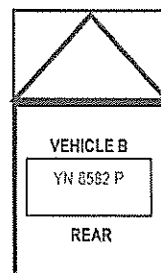

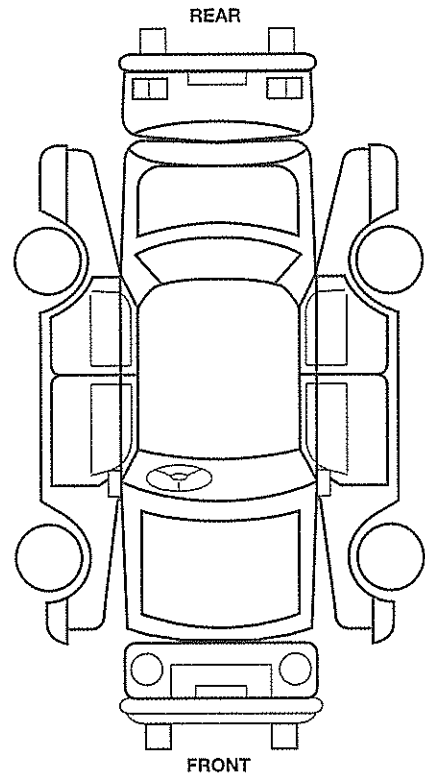
