Brief Details.

On 10/09/2018 at about 1100hrs, I parked my vehicle white-colored BMW 3 series SJY699J at the Blk 112 Aljunied Multi-Storey Carpark with everything intact. I cannot recall which deck and which lot I parked my vehicle at.

At about 1430hrs, I drove off from the MSCP without making a check on my vehicle.

At about 1700hrs, I then discovered that there was a dent to the front bumper and a crack on the front right side of my vehicle headlights. I checked my in-car camera and discovered that at about 1233hrs, there was a blue-colored Hyundai Comfort Delgro taxi SHB4166Z was reversing in the direction of my vehicle to exit the carpark gantry and the rear of the taxi collided into the front of my vehicle and left the carpark.

I wish to state that I am not the vehicle owner of SJY699J. It belonged to my mother (Pam Sew Chaw, S1134527A, 22 Canberra Drive #08-08 S768426, HP: 92976990) and she allowed me to use the car on that day. The driver of the taxi did not approach me till date to settle the issue. I have an in-car camera recording that recorded the incident.
