I, Anwar Johari (S8738330Z) was driving out of a carpark in front of Pan Pacific, opposite Marina Square at 0530 hours on 15/09/18 when I realised that the F1 race barriers had made my path too narrow to make a left turn. I had to reverse slightly to readjust my exit. Before reversing I checked the rear view mirror and saw no car near my rear. Upon reversing, suddenly a blue Hyundai taxi honked from behind. I immediately stopped and moved forward to make the left turn. The taxi honked again signalling me to stop. We parked at the side of the road and got out of the car before she informed me that we had a collision. We were surprised as neither my passenger nor I had felt any impact earlier on. I suspect that the taxi must have moved forward when I was reversing causing the 2 cars to meet, as before that my rear was clear of any car. Upon inspection of our cars we found no marks, scratches or any other form of damages on her front bumper except that there was a speck of paint on my rear bumper. She agreed but said she would check the bumper again later as there were passengers in her taxi. I inspected her bumper once again and reassured her that there were no damages to her car. Both of us amicably drove off after that. At 1208 hours that day she called to inform me that her company had found a dent in her car, and had to replace the entire front bumper. When I told her that it was unreasonable and unfair measure to take, considering we had found no damages on her front bumper that morning, she said that I should let our insurance companies settle the matter. 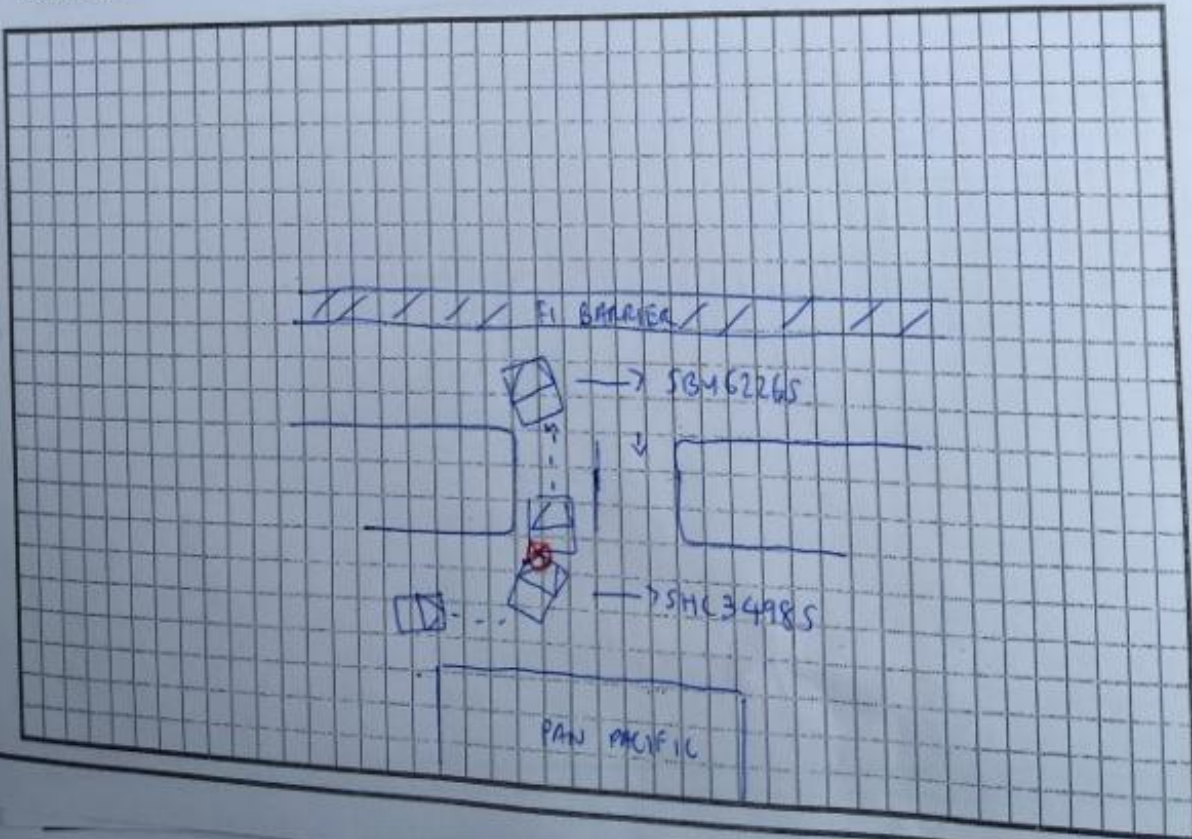
