Describe Circumstances of the Accident

I was driving along Pans Island Expressway in heavy traffic. I was on the right most lane. The cars in front were, because of the traffic, constantly stopping/braking and then moving. When I was about 1 km away from the Stevens Road exit, I wanted to begin filtering left. As I filtered left and tried to move out of my lane, a motorcycle approached at high speed along the lane divider. In my attempt to avoid the motorcycle, I moved back into the lane but due to me not noticing the vehicle in front of me, which had already halted to a stop, I ended up knocking into that vehicle (SJH T6X).

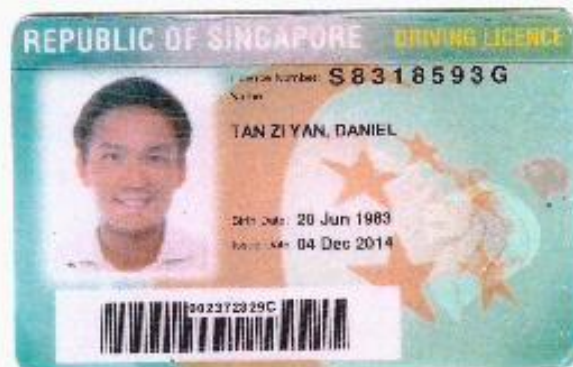
