Circumstances of Accident

ON 14 SEP 2018 AT AROUND 1520 HRS, I WAS TRAVELLING ALONG BIDEFORD ROAD TOWARDS CTE ON RIGHT LANE. MY VEHICLE WAS STATIONARY AS THE TRAFFIC WAS RED. I DECIDED TO DRIVE TOWARDS LEFT LANE AS THE TRAFFIC WAS CLEAR. I SIGNALLED MY INTENTION AND CHECKED FOR CLEARANCE BEFORE I INCHED OUT MY VEHICLE. SUDDENLY VEHICLE B CAME FROM BEHIND AND GRAZED PASSED MY STATIONARY VEHICLE AS SHE WAS TRYING TO SQUEEZE THROUGH THE MINIMUM SPACE. WE MOVED FURTHER AHEAD AND ALIGHTED TO SEE THE DAMAGES AND EXCHANGED PARTICULARS. THERE WERE ONLY PAINT SCRATCHES AND NO VISIBLE DENTS ON BOTH VEHICLES.

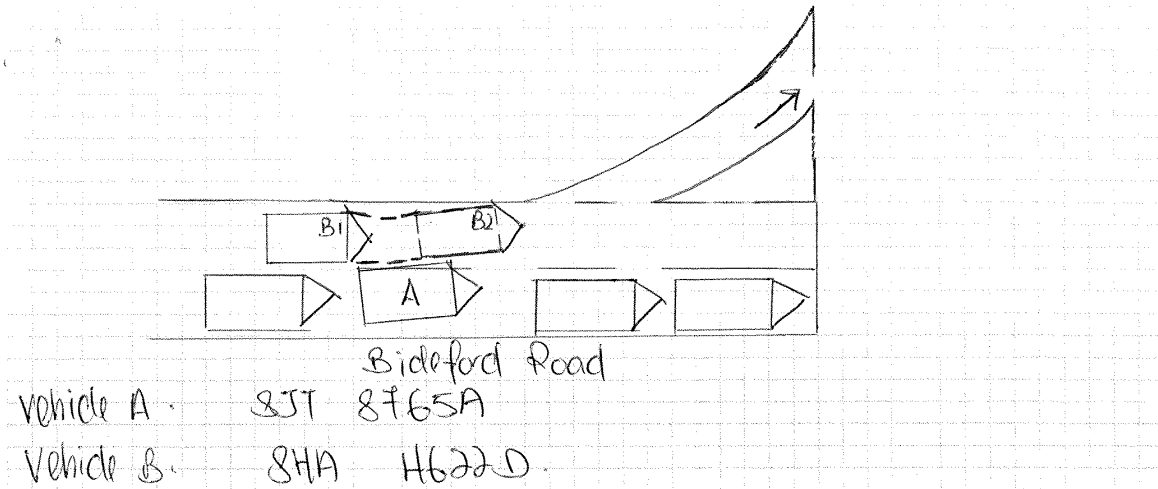





DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

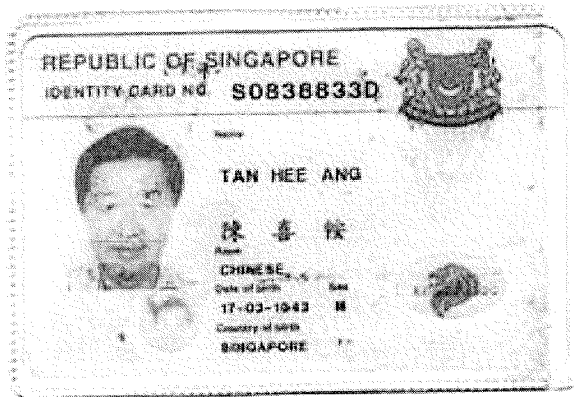
