<p>I, LCP ANG QI WEI was the transport operator on detail; together with me was 3SG TANG WEI SIONG as the vehicle commander. On 28/08/18 at 1345hrs, I was returning back from Jurong Camp 1 POL point to Pasir Laba camp. On the way back, I grazed against a double decker SBS bus (SG5496H) at a bus-stop (27301) at Block 978 along Jurong West Street 13. There were two SBS buses at the bus-stop at 1355hrs. The first bus was moving out of the bus-stop and the second bus (SG5496H) was moving into the bus-stop. I misjudged the distance between my vehicle and the SBS bus, and continued moving forward. Prior to the contact of vehicles, my VC shouted and tried to ask me to "stop" but I could not react on time. This resulted in the left side mirror grazed along the right rear of the bus (SG5496H). There were only two visible scratch marks on the right side of the bus. No passengers on the bus were injured as mentioned by the bus captain at that point of the incident.</p> <p>That is all I have to say.</p>

**Brief Details.**

On 28/08/2018, at around 1355hrs, I was driving my vehicle bearing the registration plate number MID20627 along lane 3/3 Pioneer Road North heading towards PIE. As I approach Blk978 bus stop, I came to a stop as I was about to hit onto a vehicle bearing this registration plate number SG5496H. Subsequently, a bus in front of vehicle SG5496H left the bus stop, it drove into the bus stop as such I started driving my vehicle as I believed there was sufficient space for me to pass through. While accelerating, my vehicle left side mirror hit onto the rear right side of vehicle SG5496H.

Both the bus driver and I came out of our vehicle to check on the damages and exchanged our particulars. No one was injured from the accident. No police or ambulance arrived at the scene. Vehicle SG5496H suffers slight damages while my vehicle suffers serious damages.

I am lodging this report for record purposes. I wish to state that my vehicle was equipped with a dash cam.
