I, LCP ANG QI WEI was the transport operator on detail; together with me was 3SG TANG WEI SIONG as the vehicle commander. On 28/08/18 at 1345hrs, I was returning back from Jurong Camp 1 POL point to Pasir Laba camp. On the way back, I grazed against a double decker SBS bus (SG5496H) at a bus-stop (27301) at Block 978 along Jurong West Street 13. There were two SBS buses at the bus-stop at 1355hrs. The first bus was moving out of the bus-stop and the second bus (SG5496H) was moving into the bus-stop. I misjudged the distance between my vehicle and the SBS bus, and continued moving forward. Prior to the contact of vehicles, my VC shouted and tried to ask me to "stop" but I could not react on time. This resulted in the left side mirror grazed along the right rear of the bus (SG5496H). There were only two visible scratch marks on the right side of the bus. No passengers on the bus were injured as mentioned by the bus captain at that point of the incident.
