Dear Ma'am,

I am grateful for your call the other day regarding putting forward my accident claim with respect to the accident with Comfort taxi SHA7505P and my car SKQ9822R on 25 Sept 2018 resulting in damage to my bumper and headlight.

However, I was informed by my claim agent at Performance Motors (PML) yesterday that the assessor for India International Insurance Pvt Ltd has come back with a no-liability offer of 50% claim payable only! This is quite unacceptable and I'm taken aback considering that the taxi in question was essentially running against my green light doing an illegal manoeuvre (U-turn), hence causing the accident. The taxi basically was in a spot he shouldn't have been.

I have in-fact also provided video evidence of this via the PML agent.
