We then proceeded to Balestier vicinity to have supper. During supper I had fish & chips and coke. I confirmed I did not consume any alcohol at the location. The bill was paid by Jeremy. He paid in Cash.

We remained at the location until about 0300hrs, when it started to rain. We left the restaurant hurriedly and got into my car. I was supposed to send everyone home. The 3 of them wanted to alight within Ang Mo Kio vicinity.

I was travelling along OTE(SLE), on the 4th lane. Somewhere after Upp Serangoon Exit (before Braddell Rd exit), I wanted to switch to the 3rd lane. I signalled and made the necessary checks, before attempted to switch lane. While doing so, I felt an impact from the right passenger door. I then realised that I was involved in an accident with a red transcab. We both then filtered to the road shoulder.

I then went over to the third party driver whom remained in the driver seat throughout. He wind down his window and got angry. I told him to drive forward and stop ~~at~~ under the overhead bridge as it was raining heavily.

I asked him if there was anyone injured. He did not gave any answer and continued being angry. I noticed he had one passenger at the front seat and there were also passenger at the rear seat. I was not sure how many of them exactly.
