#### **Circumstances of Accident**

ON 17/09/2018 @ 10.35HRS, I WAS AT THE ROCHOR ROAD, SERANGOON RD TRAFFIC LIGHT JUNCTION. ONCE THE LIGHT TURNED GREEN, I PROCEEDED STRAIGHT INTO BUKIT TIMAH ROAD. I AM SURE I WAS DRIVING NEXT TO THE BUS LANE. IN A FEW MOMENTS, I SUDDENLY NOTICED A BLACK CAR ON DRIVER'S SIDE PASSING BY VERY NEAR AT FAST SPEED AND DID NOT FULLY PASS BY COMPLETELY, SWERVED INTO MY LANE HITTING MY FRONT RIGHT SIDE OF THE FENDER. IT WAS A DANGEROUS AND RECKLESS MANNER IN WHICH SHE WAS DRIVING. I HORNED TO ALERT THE DRIVER BUT THE OTHER CAR SEEMED TO AVOID ME AND WAS MOVING AWAY FASTER. I KEPT SOUNDING THE HORN AND TRIED TO CATCH UP. BUT SOMEWHERE NEAR TO BOON SIEW BUILDING, THE OTHER CAR HAD TO SLOW DOWN DUE TO BEING OBSTRUCTED BY ANOTHER CAR. I WAS CLOSE ENOUGH AND WENT INTO THE BUS LANE AND CAME ALONGSIDE THE OTHER CAR AND SIGNALED THE LADY DRIVER TO STOP. WE WERE AT THAT TIME IN THE BUS LANE TOGETHER. SHE COMPLIED AND STOPPED BEHIND ME. I GOT DOWN AND INSPECTED THE DAMAGE TO MY CAR AND THEN ASKED THE LADY TO COME OUTSIDE, SHE APOLOGISED FOR HER MISTAKE AND GAVE THE REASON THAT SHE WAS IN A HURRY TO PICK UP HER FATHER TO DROP HIM TO THE AIRPORT. SHE TOLD ME THAT SHE DID NOT CARRY HER DRIVING LICENSE. IDENTITY CARD OR ANY MONEY ON HER (UNBELIEVABLE) AND SHOWED ME A PHOTO OF HER DRIVING LICENSE IN HER MOBILE PHONE WHICH SHE AGREED TO SEND TO MY PHONE. SHE KEPT SAYING SORRY AND WAS IN A GREAT HURRY AND TOLD ME THAT SHE WILL REIMBURSE THE FULL REPAIR COSTS. LATER IN THE DAY, HER FATHER CALLED ME AND GAVE ME ANOTHER STORY TOLD TO HIM BY HER DAUGHTER ACCUSING ME AND SAYING HE WILL MAKE A POLICE REPORT SINCE I WAS THE ONE WHO CHANGED LANE AND CAUSED THE ACCIDENT. AN EXPERT CAN SEE THE SCRATCH MARKS ON THE CAR AND DETERMINE HOW THE DAMAGE TOOK PLACE AND WHO IS AT FAULT.
