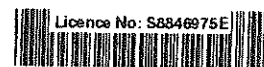

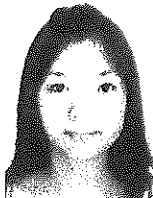

# SKETCH PLAN

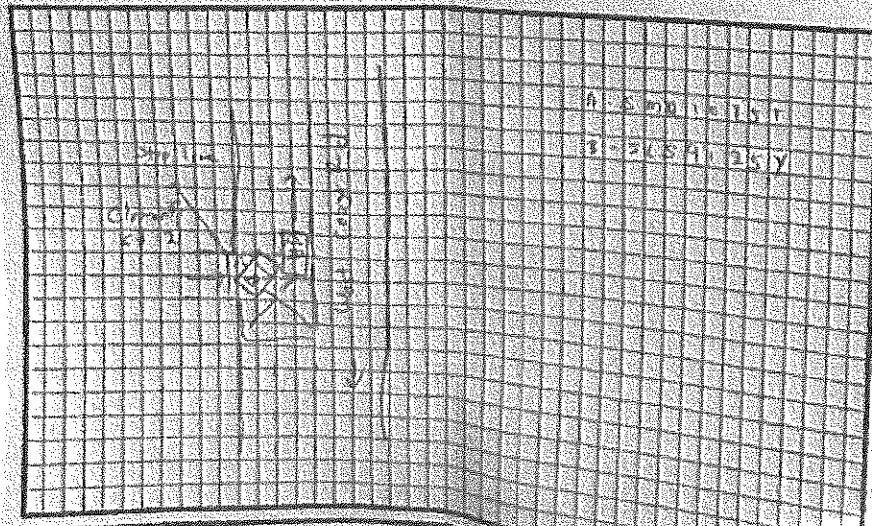
