Brief Details.

ON 23 SEPTEMBER 2018 AT 1745HRS, I WAS DRIVING MY CAR (SBG 388 X) FROM MALACCA TO SINGAPORE ALONG THE NORTH SOUTH EXPRESSWAY. DUE TO MODERATE TRAFFIC CONGESTION AT THE 33KM MARKER TOWARDS JOHOR BAHRU, TRAFFIC CAME TO A STANDSTILL MOMENTARILY. THE CAR AHEAD OF ME HAD APPLIED SUDDEN BRAKE AND CAME TO A STOP. I MANAGED TO STOP IN TIME TO AVOID COLLISION. HOWEVER, THE CAR BEHIND ME (BGY 6639) WHICH WAS A MALAYSIAN REGISTERED CAR COLLIDED INTO THE REAR OF MY CAR. REAR BUMPER OF MY CAR WAS DAMAGED. I EXCHANGED DRIVER DETAILS AND PROCEEDED TO LODGE AN ACCIDENT REPORT AT THE TRAFFIC POLICE STATION IN JOHOR BAHRU. I HAVE VIDEO FOOTAGE AND PICTURES PERTAINING TO THE ACCIDENT.
