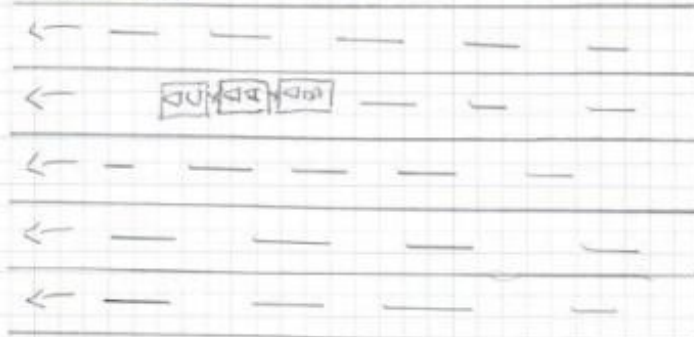

PIE changi before Paya Lebar exit




### DESCRIBE CIRCUMSTANCES OF THE ACCIDENT
