Brief Details.

On 21/09/2018 at about 1615hours, I was driving my car (SGY7883H) along Bishan Rd heading towards Braddell Rd. I was driving on the extreme right lane. At that point of time, the traffic light was red. As such, my vehicle was in a stationary position.

Suddenly, I felt an impact coming from the rear of my car. I went out from my vehicle and discovered that I was involved in a chain collision accident. Total there were 3 vehicles involved including my car.

The third vehicle (SGM7400G) had collided onto the second vehicle (GBC1787S) which then collided onto the rear of my vehicle. I also discovered that there was a motorcycle (FBE8491M) ridden by a male Chinese elderly which was also involved in the accident. The said motorcycle was on the right side of the second vehicle (GBC1787S). The rider was injured during the accident after being hit by the second vehicle (GBC1787S).

My vehicle suffered some damages to rear portion of my car. My car was not installed with any in-car
