Dear Asher,

We refer to our telephone conversation of this morning.

Our witness do not wish to give any further statement as she has affirmed a SD.

Our driver is very adamant that your insured's lorry had encroached onto his lane and drove off straight across the junction.

#### Please note that:-

- a) Your insured reported that he 'heard a honk....' Obviously his lorry has encroached onto our driver's lane so logically our driver has to horn to alert him;
- b) Your insured's is a heavy vehicle (2.4 tonnage) box lorry so you think there is any space for our taxi to encroach onto this lane especially with a huge box protruding out;
- c) The fact that your insured had failed to stop immediately after the accident proved that he is trying to escape so our driver is unable to capture any picture of the actual lying position;
- d) If our driver is at fault, our passenger would have not volunteered to be his witness and would not have advised him to make a police report. Our driver has made a report (no. S/D Ref: 66) at the Changi NPC;
- e) Your insured's lorry hit the right wing mirror of our taxi and pushed it outwards. The damage as per photos attached clearly supports our driver's version;
- f) There is no damage to the right front wheel and right front mudguard proved that our taxi was going straight and within his own lane.

Purely for the sake of an amicable settlement, we are prepared to accept a global sum of \$2,000.00 (all in). If your principal is not agreeable to settle our claim as proposed, we will escalate the matter to GIA for their deliberation. Thanks.
