**Brief Details.**

On the 02/10/2018 at about 0730hrs, I was travelling along PIE heading towards Changi near to the Toa Payoh Exit. I was on the most left lane and it was slow moving. I was then stationary and then I suddenly felt a bang at the back of my vehicle and I then got off my vehicle and checked what had happened. I then saw that the car behind me bearing carplate: SLN8639P had banged into my vehicle and there was also another vehicle bearing carplate SFZ5711R had also banged into the SLN 8639P. I had then exchanged particulars with the other drivers and then proceeded to the road shoulder as we did not want to block traffic. We then continued to wait at the side for awhile and then I had proceeded to went off as my vehicle could still be driven. The other vehicles were not in good condition to be driven and they had


