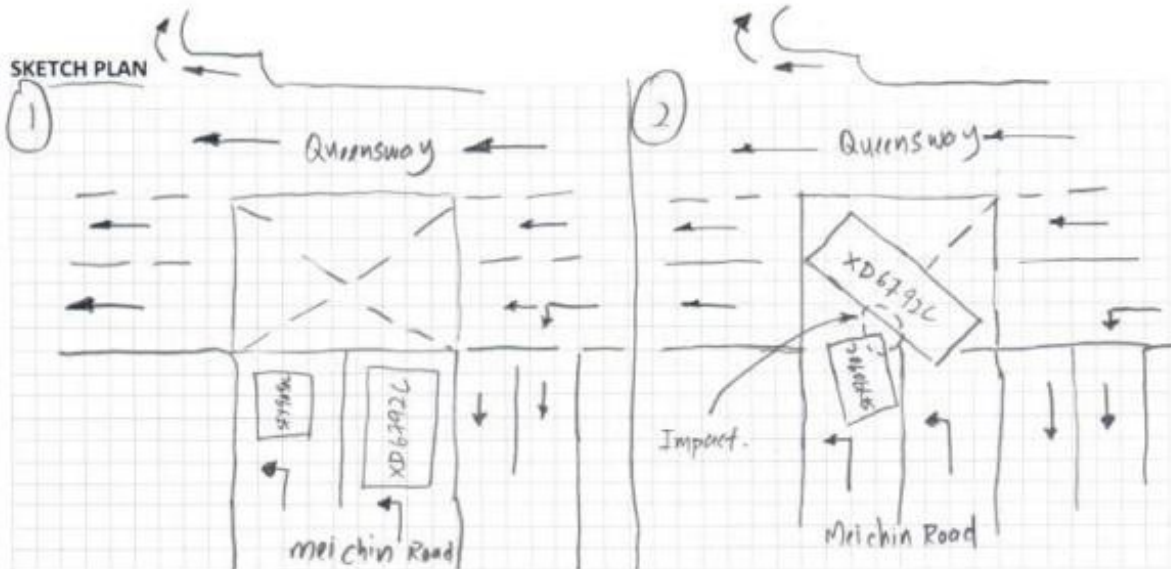

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

PICTURE (1) DATE: 10/10/18 TIME: 19:22

(SFY9090C) is travelling from Mei Chin Road. Came to the T-Junction that link to Queensway. Stopped at the T-Junction. (XD6792C) is stopped at the T-Junction also. XD6792C started to move off from the white line turning left. As a safety precaution, didn't move off immediately, wanted to allow the lorry (XD6792C) to clear the junction first. Then suddenly, (XD6792C) verged toward my side abruptly!

Lorry (XD6792C) while turning left verged sharply towards left side suddenly! (SFY9090C) horned very loudly. But the lorry (XD6792C) just turned ^{more} towards the left side with speed! Thus causing collision to my right side of my car (SFY9090C). There is no more room on my left side to move & (XD6792C) just cut into my path

* Driver came down & apologised he didn't see my car in his blind spot.

* Horned him so loudly, he said he didn't heard the horn.

* He mentioned his lorry is too tall & my car is too low (Hidden inside his blind spot)
