Brief Details.

On 08/10/2018 at about 1815hrs, I was driving my car bearing SJB8838T along Pasir Ris Drive 6 heading towards Changi North Crescent at the right most lane where the accident happened. As I was driving straight, out a sudden a police vehicle bearing QX236J drove out from a nearby carpark, PRPR7 wanting to make a right turn into Pasir Ris Drive 6 heading towards Pasir Ris Drive 3. As both vehicles could not brake on time, the front right portion of the police vehicle collided into the front left portion of my car . After the collision, both vehicles stopped and alighted from our vehicles. Both vehicles were slightly damaged. Subsequently, Traffic Police arrived at scene. No ambulance at scene. No one was injured. There is an in-car camera in my car. I am unsure if there is any CCTV nearby.
