do solemnly and sincerely declare that:

On 5<sup>th</sup> October 2018, I took motor taxi no. SHD 6122B from the taxi stand at Bukit Panjang Plaza heading home at Fajar Road. I was alone and seated at the back on the left side.

At around 22.45 hours, our taxi was travelling slowly within its own lane along Fajar Road in front of Block 422. The road is a single lane and is quite narrow.

A motor van no. GBG 8068S came from behind overtook our taxi from the right, squeezed into our path and hit onto the right side of our taxi causing the right wing mirror to crack.

The said van did not stop after the accident so that taxi driver gave chase. He gave chase until the said van went to an open space car park near Block 427 and stopped.

The van driver is very rude. Instead of peace talk, he challenged the taxi driver to report to the police.

I was angry with the van driver's attitude and told the taxi driver that I will follow him to the police station to make a report and be his witness. When we reached the police station at Segar Road, I was sitting in the station while the police is taking the statement from the taxi driver inside the room. After the taxi driver came out, he told me that the police do not require my statement so I left.

And I make this solemn declaration by virtue of the provisions of the Oaths and Declarations Act (Cap. 211), and subject to the penalties provided by the Act for the making of false statements in statutory declarations, conscientiously believing the statements contained in this declaration to be true in ever particular.
