Brief Details.

On 07/10/2018 at around 2045hrs, I was driving my vehicle (SKZ6199D) along the right outermost lane of Hume Avenue going towards Upper Bukit Timah Road. I stopped at the right light and when the traffic turned green for me to go, I checked my blind spots before making a right turn. As I was turning, the driver of vehicle (SFY528S) beat the red light and her car subsequently crashed into mine. Due to the impact, my vehicle was shifted to my left and subsequently hit the other vehicle (SJX1450H) on the lane to the left of my lane, which was also making a right turn towards Upper Bukit Timah Road. Thereafter,I got off my car and exchanged particulars with the drivers involved. Around 10 minutes later, the traffic police and the ambulance arrived at scene and one traffic police officer gave me a case card and advised me to come to the nearest police centre to make a police report.
