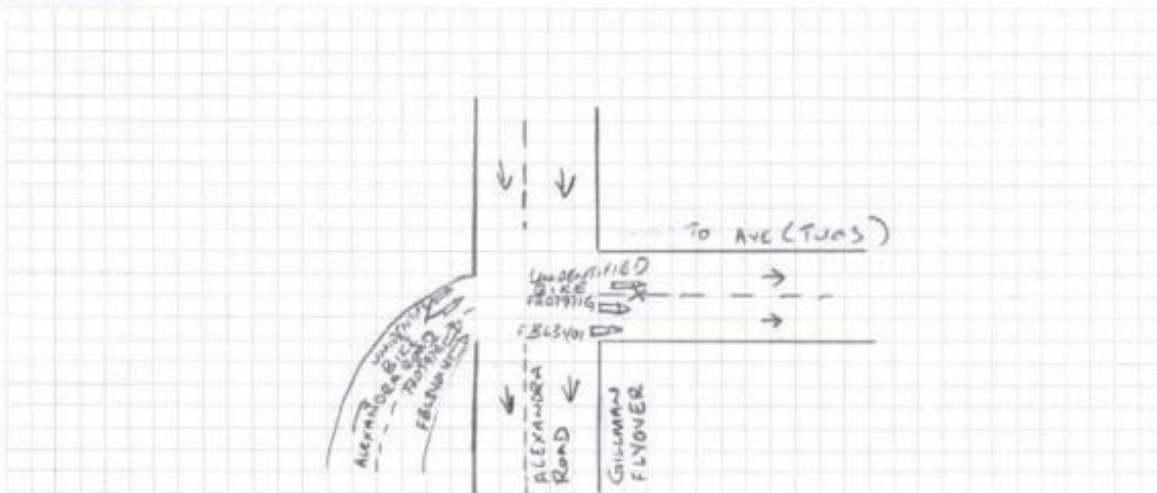

Brief Details.

On 12/10/2018 at about 1715hrs, I was riding my motorcycle registration number: FBL3401U on the right lane of the 02 lanes road along Gillman Flyover towards AYE. My wife was my pillion. We stopped at the traffic junction and there were another 03 motorcycle beside me. When the traffic turned to my favor, I continued to ride forward to perform a right turn. As I was riding forward, I took a glance on my left side and I noticed that there was a Honda CB400 motorcycle registration number: FBD7971G riding closely to another motorcycle (I did not notice the registration number). Subsequently the CB400 rider fell down in front of my motorcycle and I applied emergency brake and avoided him, I immediately alighted my motorcycle to render aid. There is no CCTV on my motorcycle and I am not aware of what caused the

My wife who was my pillion observed that both the CB400 rider and another rider were riding very closely. And it seems like the CB400 rider was trying to avoid collision with the other rider, thus he fell down onto the road. I suffered a burn at the back of my thigh as my leg contacted with my exhaust pipe while trying to avoid collision with the CB400 rider. My pillion suffered pain at the back and pelvis area but none of us were conveyed to hospital.

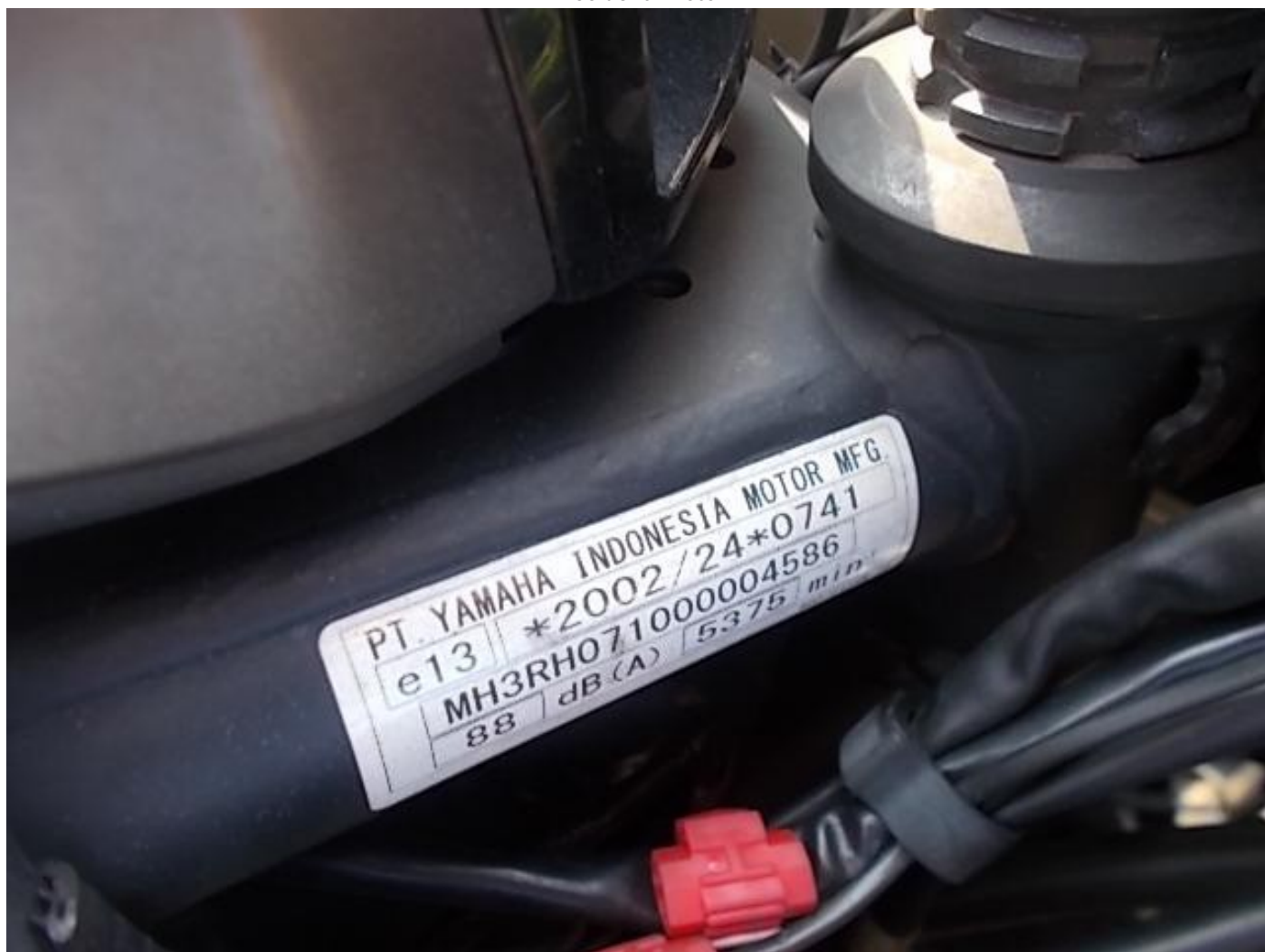
