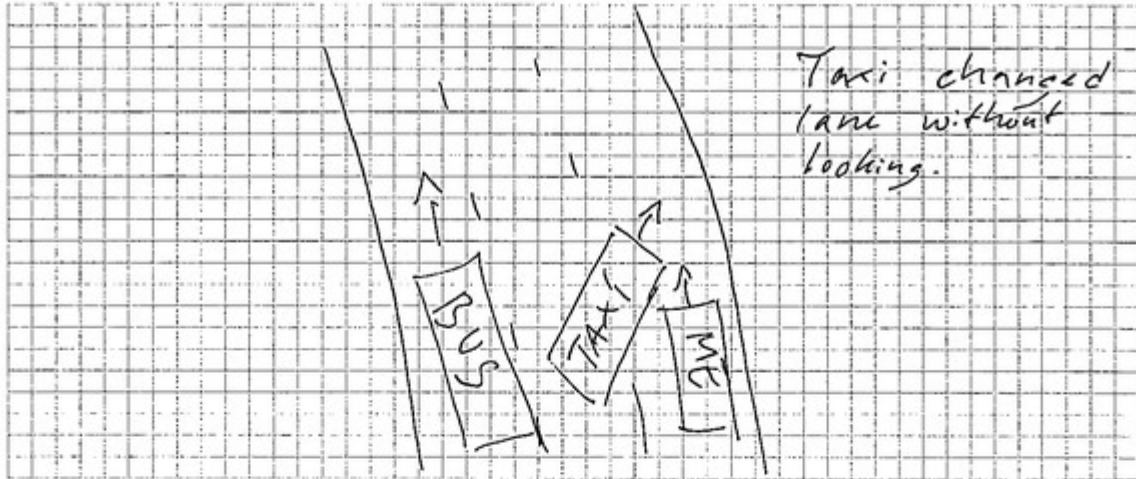

SKETCH PLAN


