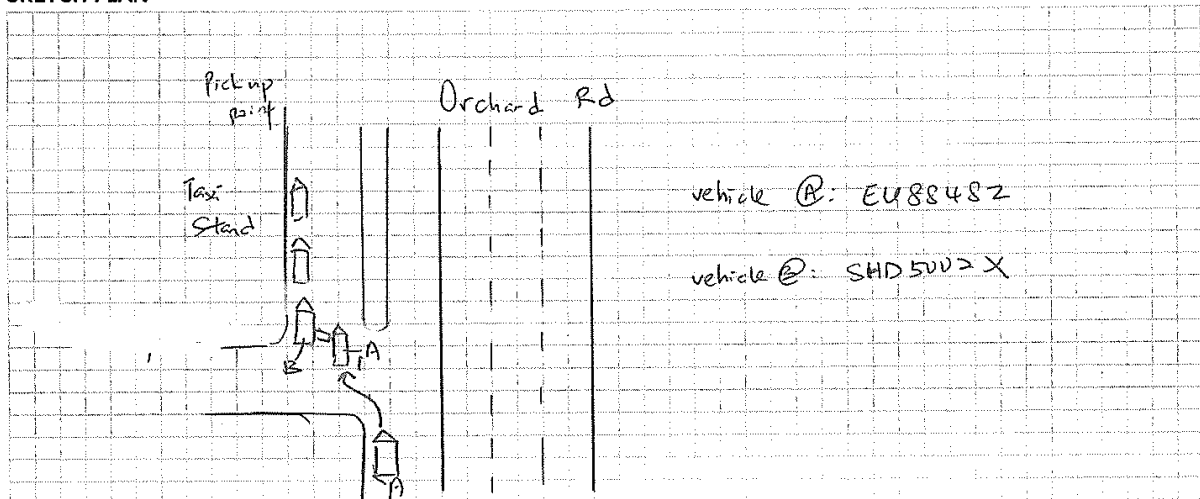

## SKETCH PLAN



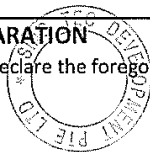

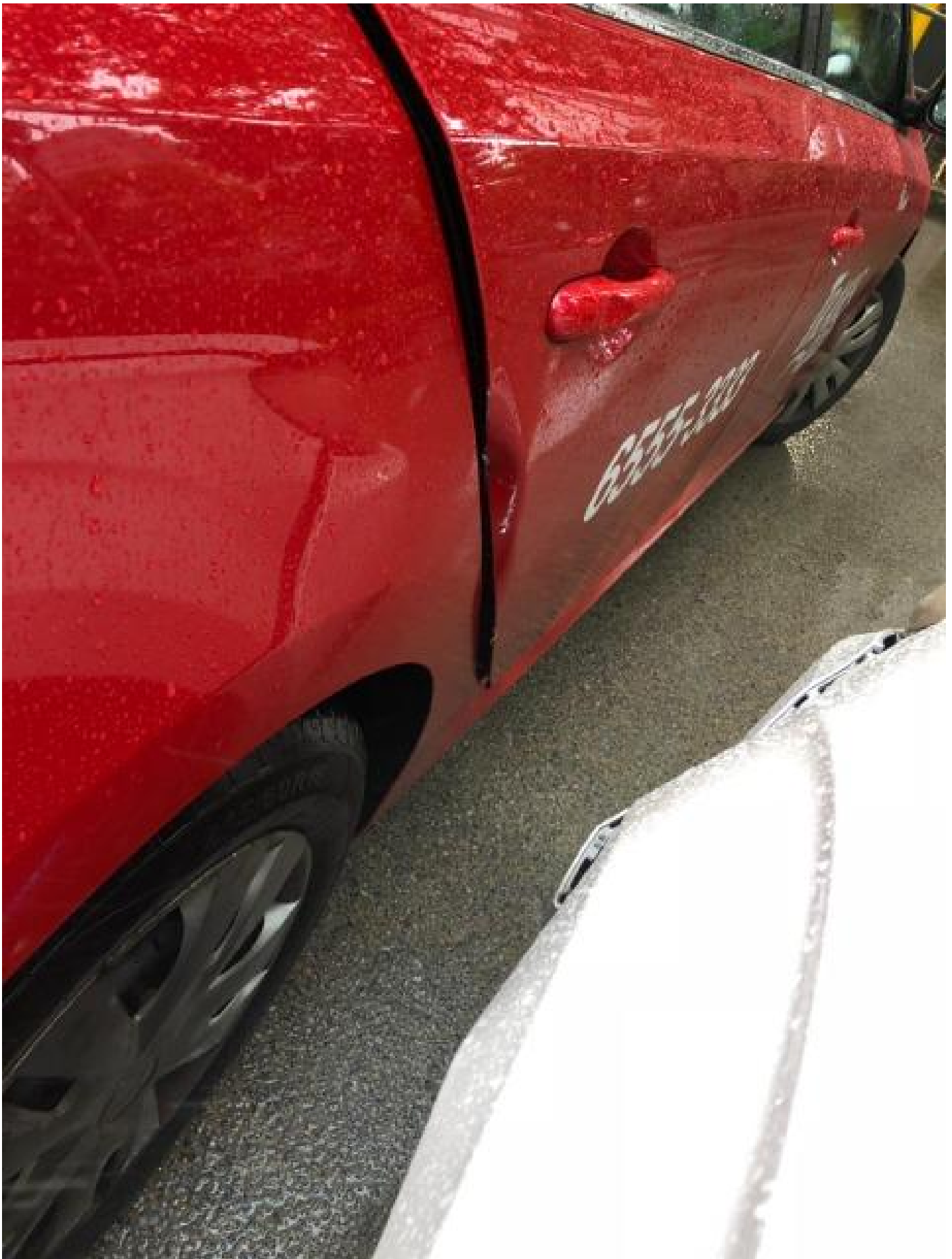
