

Describe Circumstance of the Accident.


ON 15/10/2018 AT ABOUT 1940HRS, I WAS DRIVING MY TAXI (SHC 6283 A) TRAVELLING ALONG ROBINSON ROAD INTO THE JUNCTION OF CROSS STREET IN THE EXTREME LEFT LANE WITH A PASSENGER ONBOARD.

TRAFFIC LIGHT WAS GREEN ON MY ROUTE FAVOUR & I PROCEED AHEAD - MAKING MY LEFT TURN INTO CROSS STREET BUT SUDDENLY VEHICLE B (SHD 8595 G - CITY CAB) WHICH WAS INITIALLY BEHIND MY TAXI, HAD OVERTAKE MY TAXI ON MY RIGHT ABRUPTLY & COLLIDED ONTO THE FRONT RIGHT PORTION OF MY TAXI.

DUE TO THE IMPACT, MY TAXI HAD DAMAGES ON THE FRONT RIGHT PORTION & VEHICLE B HAD DAMAGES ON THE LEFT REAR PORTION.

NO INJURY INVOLVED.
VEHICLE B HAD PASSENGERS ONBOARD.
