I have gone through with Mr Sellavel Sathesh, driver of our Company vehicle YN3255S.

He explained that on the day of the accident, he was travelling from Geylang Road towards the direction to Kallang Road/Lavender Street.

He was travelling in lane 3 (refer to attached sketch) in the direction towards Kallang Road/Lavender Street. Approaching the traffic junction of Geylang Road/Sims Way, he intended to switch to the 2nd lane to travel straight towards Kallang Road/Lavender Street. He said he already saw the driver of van GBF230Y travelling in 2nd lane to his right which is quite a distance beside his lorry has signaled his intention to turn right. Thinking that the driver of van GBF230Y is going to turn right, Mr. Sellavel Sathesh signal right as he wanted to switch lane to keep in 2nd lane to go straight in the direction of Kallang Road/Lavender. However, the driver of van GBF230Y change his mind to travel straight instead of turning right. He tried to swerve out his lorry to the left to prevent colliding with the oncoming van but the van is too close to my lorry and glided the front of his lorry (refer to photo no.1)
