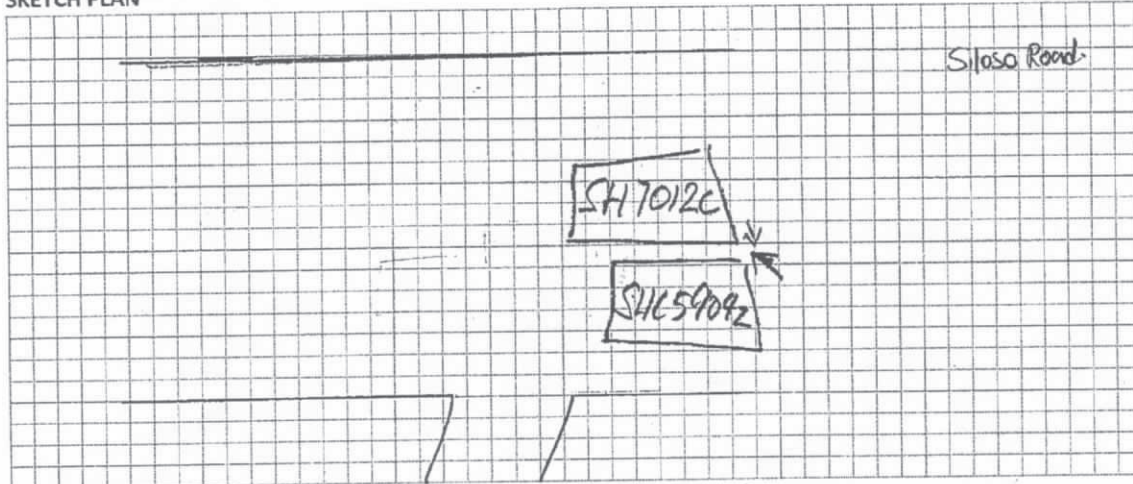

SKETCH PLAN



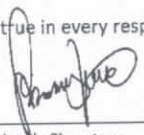
