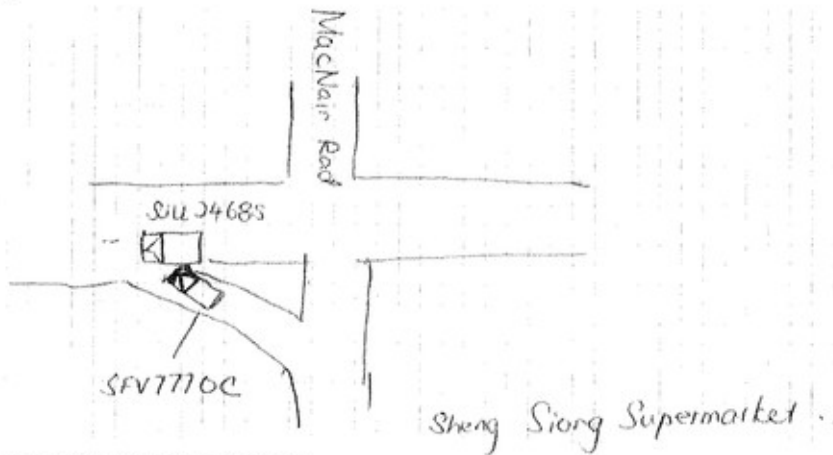




I Loh Soon Seng (NRIC No 1237883A) was driving out from Sheng Siong Supermarket making a left turn.
